**INFLATABLE BOUNCE HOUSES - INFLATABLE RIDES & GAMES
RENTAL AGREEMENT, RELEASE AND ASSUMPTION OF RISKS**

ALL BOOKINGS MUST BE PAID FOR PRIOR TO DATE OF ENGAGEMENT

ALL BOOKINGS MUST BE CANCELLED 3 DAYS IN ADVANCE TO AVOID LOSS OF DEPOSIT

Terms & Conditions/Warranty:

1. At the time of accepting delivery of rented items/equipment, the customer agrees to all of the written terms and conditions on this rental contract. The customer also acknowledges that he/she is at least 18 years of age and agrees that they have received all of the rental items on their contract in good order.
2. Customer agrees to assume full responsibility for all of the rented items during the period of time in which the rentals are in their possession including safe and proper use, operation, maintenance and return to Got Game Rental. Customer is fully responsible for all loss, damage or repair.
3. Recovery of Equipment: If customer fails to return all rented items by the agreed time, the customer agrees to pay for any additional charges that are incurred as a result. If customer refuses to return the rental items back to Got Game Rental, then the customer agrees that Got Game Rental, and its agents, will take all reasonable actions needed in order to recover the rented items without legal process or advance notification.

Release & Liability:

1. Duty of Participants: It is recognized and understood that some of the activities offered and conducted by Got Game Rental can be hazardous to the participants regardless of all possible safety measures that can be taken. All participants have a duty to act responsible and prudent when engaging in the recreational activities, which are provided by Got Game Rental.
2. I understand and acknowledge that the activity which I am about to voluntarily participate in bears certain know risks and possible unanticipated risks which include and are not limited to the following: slipping, crashing, falling and colliding and could result in illness, injury, emotional distress, disease and property damage to myself or anyone of guests/invitees.
3. In consideration of the service and property provided, I not only for myself, but for any minor children for which I am the parent, legal guardian or otherwise responsible, any heirs, personal representatives or assign, do hereby release and hold harmless Got Game Rental, it's principals', directors, officers, agents, employees, volunteers and anyone else of affiliation from all liability and waive any claim from damage or injury that may arise from any cause whatsoever.
4. Lessee agrees to supervise both the equipment and its use at all times that said equipment is in the possession of the lessee. Accompanying this contract is a set of directions for use, along with safety rules that I agree to utilize and follow at all times during the operation of this ride, inflatable game or any other piece of equipment that was rented from Got Game Rental.

I HEREBY AGREE NOT TO DO THE FOLLOWING:

- Engage in any conduct that willfully or negligently contributes or causes injury to any person.
- To embark in any self initiated activity without first informing Got Game Rental to engage in such self initiated activity.

Safety Rules and Operating Instructions:

I AGREE TO THE FOLLOWING RULES AND OPERATING INSTRUCTIONS:

1. Ensure that all safety rules and operating instructions are posted on the front of the inflatable, as well as any written and/or verbal instruction that are provided are all followed.
2. In the case of high winds that are 25-35 mph or stronger, or any other potentially dangerous inclement weather, have all persons exit the inflatable or ride, then unplug the unit to let deflate.
3. Remove all sharp or pointy objects from pockets. For example: jewelry, cell phone, keys, pens, pencils, etc.
4. No food, drink or gum allowed on the rides or in the inflatable units.
5. Remove shoes, pens, pencils, earrings, eyeglasses, cell phones, rings and jewelry.

6. NO SILLY STRING is permitted to come in contact with either the inside or the outside of any of the rental units. If the inflatable as a result of SILLY STRING THEN THE CUSTOMER AGREES TO REPLACE /REPAIR THE DAMAGED UNIT AT COST. A \$4,000 fee will be imposed to replace or repair damaged rides, inflatable games and bounces. If the current replacement value of the rented equipment that is damaged exceeds the original \$4,000 fee, any additional fees beyond that will also be imposed on the client by signing this agreement.
7. Do NOT climb on the netting or sidewalls of the rental unit.
8. Do NOT bounce near the entrance or up against the sidewalls. Also, do not bounce into corner posts.
9. Make sure the kids are a safe distance away from each other when they are participating on rides, interactive games and bounces.
10. Do NOT jump off the slide.
11. NO jumping or sitting on the entrance ramp.
12. Make sure participants are of the same size on the ride.
13. Follow the maximum number of riders and the maximum weight limit posted on the inflatable units.
14. Make sure the inflatable does not rub up against any other surface.
15. Once the bounce unit is set up by Got Game Rental, it is NOT to be moved.
16. NO flips, somersaults, wrestling, pile up or rough play of kind.
17. Those who are NOT permitted in the unit at any time are: those with head/neck or back injuries, disabilities, heart conditions, small infants, pregnant women and others who may be highly susceptible to injuries from bouncing, bumps and falling.
18. NO water will be permitted inside or around the inflatable unless the unit was specifically manufactured with the intention of use with water.
19. If the inflatable starts to deflate, please have all the riders exit the unit immediately, and then check the following:
 - a. If the blower motor has stopped. If so, check the power cord connection to make sure it is still in place. If the power cord is in good standing, then check to make sure the circuit breaker was not tripped, or GFI outlet/receptacle was not tripped for any reason.
 - b. If the blower motor continues to run you want to check for a blockage of air intake on the side of the blower unit. Check all air tubes that are located on the back of the inflatable to ensure they are still snug. If needed, tighten the ties.

- c. If the following step A or B remedies the situation, then you can fully re-inflate the unit. Make sure the unit is fully inflated before allowing anyone to use it. If you cannot correct the problem, please call the emergency number that was provided to you at the time of delivery or try contacting our office.

Client Signature & Agreement of Terms:

I agree to follow and use these Safety Rules and Operating Instructions at all times during the term use and operation of all equipment. I am of at least 18 years of age as of today's date and fully consent to this agreement as it is written. I understand the risk of liability that is presented in renting the contracted equipment from Got Game Rental.

By signing this contract agreement, I hereby acknowledge and also certify that I have sufficient time to thoroughly read this document in its entirety. I fully understand all of it's contents and that I execute it intelligently, freely and without any duress. I agree to be bound by its term, for the services being provided by Got Game Rental.
